# Introduction

#### Summary from last ICG related to the TT-Doc

- The TT-Doc had started the revision of the Interim Operational Users Guide (IOUG, 2011) to be drafted before the Steering Committee in spring 2022. The session noted that experts directly affiliated with TSPs would be better technical expertise to take on this task.
- Mr Öcal Necmioğlu proposed partial updates to the ICG/NEAMTWS Operational Users Guide. For example, WGs and TTs (e.g. TT-OP) can provide updates on the guidance on sea level measurements, or improvement on the ongoing messages. He highlighted that improvements can be done partially and be approved by the ICG/NEAMTWS once every year.

#### **Progress since last ICG**

- The new TT-Doc co-chairs collected the available information on the existing IOUG.
- A new IOUG structure (table of contents) was drafted between the co-chairs.
- The TT-Doc co-chairs arranged a meeting with the past TT-Doc and present TT-OP co-chairs to discuss the proposed restructuring of the IOUG and received their feedback.

# TT-Doc progress summary

- The current IOUG drafted in 2011 needs updating and restructuring to become more efficient and i) reflect current NEAMTWS TSP/NTWC operations, and ii) provide clarifications for key TSP/NTWC operational topics not currently described.
- A new (ambitious) IOUG structure was drafted.
- The proposed restructuring of IOUG was discussed with the TT-OP co-chairs co-chairs (and one of the past TT-Doc co-chairs).
- The existing IOUG, the ICG/NEAMTWS Implementation and Strategy documents, as well as the IOC/TOWS-WG GSDD shall be taken into account when drafting the updated IOUG.

#### Next steps

- Compile a list of open issues currently discussed in the TT-OP, and identify which issues need to be resolved before finalizing the updated IOUG (e.g., the use of threat levels);
- Discuss this list at the next ICG and keep addressing them in the intersessional period;
- Search for volunteers within the ICG to contribute to start drafting- before 2022 ICG already sections of the updated IOUG;
- First draft of updated IOUG at ICG in 2023.
