Dear Sir/Madam,

As you may recall, the Joint WMO-IOC Data Buoy Cooperation Panel (DBCP) is an official body of the World Meteorological Organization (WMO) and of the Intergovernmental Oceanographic Commission (IOC) of UNESCO.

At its thirty-eighth session (DBCP-38) held in Geneva, Switzerland, in November 2022, DBCP noted its continuing success in regional training workshops held in 2010–2022. It endorsed future support for continued activities in this regard, including supporting, through the DBCP Task Team on Capacity Building (TT-CB), to organize the "First Mediterranean Training Workshop on Ocean Observations and Data Applications-Part 2" (Medi-1 Part 2) in 2023.

You may recall that Part 1 of the Medi-1 training workshop took place as a virtual session from 9 to 11 November 2022. Part 2 will be a continuation of Part 1 which will take place as a hybrid session from 2 to 4 May 2023, in Tunis, Tunisia with the kind invitation from the National Institute of Meteorology (INM), Ministry of Transport, Tunisia.

The objective of the workshop is to enhance Mediterranean region capacity to apply ocean observations for social and economic benefit, and to improve the forecasts. The themes for the workshop will include information on the role of ocean observations for regional weather prediction and climatology, societal and economic benefits of ocean observations, best practices, data quality control and ocean observing with new technologies, data access and data applications, data quality control and ocean observing capacity in the region, as well as continuing the discussion from Medi-1 Part 1 on the regional observations, quality control and data applications in forecast improvements.

The workshop is primarily designed for ocean forecasters, ocean data managers, observation instruments operators from the Mediterranean region, especially from Developing States. The workshop will be conducted in English only. Attached herewith is a copy of the workshop goals (Annex 1), for your information. The programme, local arrangements (i.e. accommodation, visas, etc.); and any other information pertinent to the workshop will be posted, in due course, on the GOOS web page. Trainers for the workshop are being drawn from a wide spectrum of the international ocean community.

I encourage you to nominate potential Medi-1 Part 2 trainees using the attached Nomination/Registration Form (see Annex 2). The Workshop will offer an exceptional opportunity for participants to learn new skills, and to make significant and ongoing contributions to major international programmes. Please note that a similar invitation letter to this event is being circulated by the IOC/UNESCO.

A selection committee will be set up with a view of selecting from all the nominations received, the most qualified experts in the area of marine meteorological, oceanographic (met-ocean), forecasting or met-ocean observations. The selection committee will deliberate by the beginning of March 2023 and will inform the selected experts soon after.

Non-staff members of WMO who are authorized to travel at the Organization's expense and/or who are receiving a DSA from WMO must ensure they are fully responsible for expenses incurred in the event of death, illness or injury during official travel and attendance at meetings on behalf of the Organization. They are, therefore, fully responsible for arranging life, health, accident, as well as any other forms of insurance with an adequate level of coverage for the duration of such meetings and events.

WMO liability is limited to the performance of services or attendance at a meeting on behalf of the Organization, is covered by an injury and illness benefit insurance which provides a limited coverage for medical, emergency and supplementary official travel expenses.

In order to allow sufficient time to consider all the nominations and complete the selection process in a timely fashion, it would be greatly appreciated if your reply could reach the WMO Secretariat, as soon as possible, but preferably **no later than 24 February 2023** for the attention of Ms Champika Gallage (Scientific Officer, Marine), at cgallage@wmo.int, copy to Ms Ting Yu at t.yu@unesco.org. Also, it should be noted that selected participants will be required to present a valid passport (six months beyond the date of travel) and obtain the necessary entry and/or transit visas, in due course.

Finally, I look forward to the active participation of all attendees in this important and rewarding event. In this context, you are welcome, in your capacity of Permanent Representative of your country with WMO, to nominate experts from either your Meteorological Service, or any other national institutions specializing in the subject field.
