Subject: Invitation to the Thirty-second Session of the IOC Assembly, 21–30 June 2023 and Fifty-sixth Session of the IOC Executive Council, 20 June 2023, UNESCO HQ, Paris

It is my great pleasure to invite you, on behalf of the IOC Chairperson Mr Ariel H. Troisi, to attend the 32nd Session of the IOC Assembly. It will be held at UNESCO Headquarters on 21–30 June 2023. States members of the IOC Executive Council will meet for the 56th session of the Council on 20 June 2023, one day before the Assembly. This session will act as the steering committee for the Assembly. Also, Executive Council members will participate in the consultation process for the appointment of the next IOC Executive Secretary. Please expect a dedicated circular letter on this specific issue.

The provisional agenda for the Assembly provides a global overview of the developments of the Commission' activity over the biennium, mostly through the reports of IOC subsidiary bodies. Some reporting items requested by the Assembly and Executive Council at their previous sessions will be addressed in my report under item 3.2. The provisional agenda and timetable attached hereto have been prepared in consultation with the Officers during their meeting last January. In view of the technical nature of some items on the agenda, it would be much appreciated if consideration is given to the inclusion in government delegations of representatives and experts conversant with the subject matters of the session. Let me also cordially reiterate to Member States the need to give due consideration to gender balance in the composition of their delegations.

The Action Paper is the guiding document for the session. It contains initial draft of formal decisions and draft resolutions proposed by Member States for each agenda item. Let me invite Member States and partner organizations to liaise closely with the secretariat on the drafting of decisions of the session. Please kindly do so as early as possible. The Action Paper will be available on the

As customary, decisions will be reviewed on-screen and adopted immediately after an agenda item is discussed.

<u>Draft Resolutions</u> (DRs) should be presented by one or more Member States in accordance with document <u>IOC/INF-1315</u> by Friday 16 June, 10 a.m. at the latest, with the exception of the Draft Resolution on Governance, Programming and Budgeting Matters of the Commission to be submitted during the session by the Financial Committee. A form for the submission of DRs is attached.

As stipulated by Rule of Procedure No. 9, <u>supplementary items requiring a decision</u> may be submitted to the Secretariat by any Member State of the Commission or partner organization not later than two months before the beginning of the session, i.e. 21 April 2023. Requests for supplementary items should be submitted to the Secretariat along with a short working document composed of a brief background (not more than 800 words), the action requested from the Assembly, the indication of financial implications if any, and a draft decision.

In addition to the formal plenary discussion, an <u>Ocean Science Day</u> (OSD) is organised on 22 June to discuss current challenges in ocean science, potentially with a wider audience. The two main items of OSD will be a discussion of opportunities and challenges for adaptation and mitigation to ocean change, followed by a session highlighting the existing contributions of IOC to the UN Decade of Ocean Science for Sustainable Development, and a dialogue on the perspectives, benefits and challenges for future increased contributions by IOC programmes and regional subsidiary bodies to the Decade.

The <u>elections</u> of the Officers of the Commission and the members of the Executive Council will take place during this session of the Assembly in accordance with the technical arrangements appended to the <u>IOC Rules of Procedure</u>. Candidatures must reach the IOC Secretariat at latest two working days before the day of the elections scheduled on Wednesday 28 June 2023.

For security reasons and organizational purposes it is particularly important that IOC Members States and partner organizations first notify the Secretariat of the complete list of their <u>delegation</u> with names of designated Head of delegation, representatives, alternates and advisers for the session by order of precedence, with copy to their Permanent Delegation to UNESCO when relevant. In addition, all participants to the sessions must be registered individually on the dedicated online registration platform, which will be open at <u>https://ioc-registration.civi-go.net</u> from 15 April. If you need further information or assistance, please refer to the session website or contact the Secretariat (c/o Patrice Boned, <u>p.boned@unesco.org</u>).

Due to the high level of activity at headquarters during the month of June, delegations wishing to organise an event or offering a "coffee service" during the session are invited to contact the conference service or the catering service as soon as possible and to inform the Secretariat. The list of <u>side events</u> and their locations will be displayed on the Assembly webpage.

In the margins of the Assembly, Member States are also reminded that each "Electoral Group" will be invited to select one expert member of the <u>GOOS Steering Committee</u> for the two-year term, from 1 January 2024 to 31 December 2025, in accordance with the IOC Resolution XXVI-8 establishing the GOOS Steering Committee. These five experts will have, in addition to their technical expertise, the role of providing policy advice and guidance to the GOOS Steering Committee in order to align GOOS activities with decisions of the IOC Governing Bodies. Please note that the working language of the GOOS Steering Committee is English. The IOC Vice-Chairs will lead the final selection process amongst Member States of the electoral group they represent, if possible by consensus, and present candidates for appointment during the 32nd Session of the Assembly. Nominations with the candidate's CV should be submitted to the GOOS secretariat (f.collins@unesco.org) not later than 30 April 2023.
