

- at the heart of Europe


- bordering the Southern Bight of the North Sea

Millennial tradition of maritime trade has shaped Belgian urban developments and economy






An MSP in support to the Belgian Blue Economy



Priority for the coming year:

Establishing up the national committee

- RBINS, ILVO, MDK, VLIZ
- Main funders : BELSPO and EWI
- IOC delegates : BELSPO and EWI
- Link with NDC : BELSPO or VLIZ?
- Private companies : Blauw cluster?

Priority for the next 2-3 years:

- Extending the national committee to Universities (if relevant)
- Extending scope to OO activities made in deep ocean and polar regions
