

- About 500 persons were participated in IOWave23 exercise in two sites:


- Chabahar : totally 300 persons involved in the exercise at three location in the Chabahar City
- Jask : totally 300 persons participated in the Jask City










نقشه آبگرفتگی بندر جایهار در اثر سونامی مطابق با زلزله با بزرگی Mw
