## Subject : Starting of issuance of experimental NWPTAC Enhanced Products on 20 December 2017

Through IOC Circular Letter 2535 dated 4 September 2014, States members of the Pacific Tsunami Warning and Mitigation System were informed of the start of issuance of PTWC Enhanced Products for the Pacific Tsunami Warning and Mitigation System (PTWS) on 1st October 2014.

In pursuit of continuous improvement for PTWS tsunami warning products, Japan announced the same year at the IOC Executive Council that the North West Pacific Tsunami Advisory Center (NWPTAC) would also be developing new products based on the requirements of user countries. The PTWS Steering Committee (PTWS SC) agreed shortly after on a timeline targeting full transition to NWPTAC Enhanced Products by 2018. It also recommended that the Japan Meteorological Agency (JMA) continue the process of developing NWPTAC Enhanced Products for PTWS.

At its 26<sup>th</sup> session (Honolulu, April 2015), the Intergovernmental Coordination Group for the PTWS (ICG/PTWS) agreed that NWPTAC should proceed with its development of Enhanced Products for the Northwest Pacific region. Accordingly, Exercise Pacific Wave 2016 (PacWave16) and Exercise Pacific Wave 2017 (PacWave17) were conducted to evaluate NWPTAC Enhanced Products.

At its 27<sup>th</sup> session (Tahiti, April 2017), the ICG/PTWS agreed that NWPTAC should start issuance of its experimental NWPTAC Enhanced Products in parallel with its existing products in the second half of 2017 and set a target change-over date for around six months to a year from the date of introduction.

He noted that NWPTAC will extend its area of service with full changeover with the following improvements from previous products: new forecast points, 5 categories of tsunami amplitude classification and 3 graphical products.

The PTWS SC agreed to start the experimental issuance of NWPTAC Enhanced Products on 20 December 2017.

A draft Users' Guide based on the document "Operational Users Guide for the Pacific Tsunami Warning and Mitigation System (PTWS)" (IOC Technical Series No 87, 2<sup>nd</sup> Edition—mainly section 6) has been prepared and is attached to this circular letter. We kindly ask Member States to review the products and provide feedback on the products and on the draft Users' Guide. The plan is to issue the Users' Guide as a new volume of the IOC Technical Series.
