Progress and Achievement in 2024/2025

- Celebrated 25 years of IOOS in March 2025
- New High-Frequency Radars installed in Alaska, Maine, and Florida
- Backyard buoys app launched
- Ocean Enterprise Accelerator phase 2 awards 4 totalling \$54M began in January 2025
- Harmful algal bloom offshore monitoring project meets success
- Researchers complete 12-year retrospective of LiveOcean model
- U.S. IOOS Regional Associations awarded \$101.5 M to support ocean observing
- ICOOS Act Reauthorization legislation introduced
- Progress on the development of the Benefits of Ocean Observing Catalog (BOOC)





BENEFITS OF OCEAN OBSERVING CATALOG (BOOC)

Purpose: BOOC will illustrate the ways in which different types of ocean information are used across regions and what benefits are gained.

Methodology:

- Based on GIS and database tools, BOOC will enable the community to easily submit systematically structured use cases of the socioeconomic benefits of ocean observations, measurements, and forecasting.
- All use cases will undergo peer review and will be published as short papers, each with a unique Digital Object Identifier (DOI).

Outcome: Users will be able to search by attributes such as geographic location, the type of data used, the beneficial outcomes, and others.

BENEFITS OF OCEAN OBSERVING CATALOG (BOOC)

Updates: We are currently conducting final testing within IOOS of the BOOC website and submission portal. The database will be initially populated with use cases provided by IOOS Regional Associations and internally within NOAA prior to opening for public submissions.

Call for Cases: The BOOC development team plans to open the site to the GOOS GRAs for use case submissions around the end of May.
